### Kinsmen of the Year/Kinette of the Year

(They will be awarded in each Zone)

To qualify for this award, you must be nominated by a fellow Kin in your home zone. The person doing the nominating is asked to write a letter outlining the nominee's Kin achievements and why they think the nominee should be honored as Kin of the Year.

**Deadline: May 15, 2018** 

## **KIN-Educate Club Award**

- A membership promotion award
- To compete, a club must complete the following:

#### Mandatory:

- 1. Have Kin Education at a meeting
- 2. Complete and forward District and National dues, insurance papers and incorporation forms on time.

#### Any five of seven:

- 1. Increase club membership by 2 kin the Kin Year
- 2. Designate one meeting as 'Bring A Buddy' night or plan a recruiting event.
- 3. Have your club's picture in the local paper doing service work or fundraising. A copy of the article must be included in the application.
- 4. Plan a fun event for the club on a non-meeting night.
- 5. Club must be represented at FLC, Spring Zone meeting and District Convention. (This piece obviously deter-mined at convention)
- 6. At least 3 members do a visitation to another club.
- 7. Compete for at least one District Award.

Must be completed on or before May 15, 2018.

## Kin Quill Award

- The purpose of this competition is to encourage Kin to provide articles for SasKin.
- Any District 3 Kin in good standing is eligible to participate.

#### **Submission Guidelines:**

- 1) Story may be on any subject of interest to Kin with the following exclusions:
  - Personal political views
  - Negative or derogatory commentary deemed offensive to the Association
- 2) Story must be written in good taste and must be a minimum of 600 words and a maximum of 1000 words in length; each and every word will be counted as one word. NOTE You must indicate the number of words on your Quill Award score sheet. Quill submissions over or under the limit, or those without a word count on the cover pate or at the top of the first page, will be disqualified from judging.
- 3) An original copy of the Quill entry, labeled as such, shall be sent to the District Governor or District Awards Chair (or their designate) who is responsible to ensure that the submissions have met the criteria of the national competition including:
  - Word Count minimum 600, maximum 1000
  - Writing Ability
  - General interest to Kin
  - Story written in good taste
  - Originality and presentation
- 4) Submission of the story must be accompanied by a 25-50 word biographical sketch of the author, included with each entry on a separate sheet of paper or the submission will be disqualified.
- 5) Submission of the story must be accompanied with the author's signed acknowledgement or the submission will be disqualified.

Submissions must be e-mailed to sask.kin@gmail.com with 'Kin Quill Award' in the subject line by May 1, 2018.

## **Outstanding Kin of the Year**

By written submission, the nominating party must outline why they feel one District 3 Kin member deserves the honor of being recognized as most exemplifying the Objects of our Association.

#### **Bulletin Award**

Junior Category - Clubs with 12 members or less

Senior Category - Clubs with 13 members or more.

Judging Criteria:

- Must have club executive listed
- Minutes from previous meeting
- Club Roster
- Upcoming events
- Overall appearance

## **Elmer Miller Visitation Award**

The purpose of this award is to help stimulate more inter-club visitations within District 3.

The following rules shall apply:

- In order to qualify as a visitation, a minimum of three Kin from the visiting club must attend one of the following functions of any other club in District 3 A regular meetings, an installation nights, a Founder's night, or a club anniversary night. Points will be awarded as follows with the total being the sum of A, B and C:
- A. 5 points for the minimum of 3 members visiting
- B. 1 point for each additional member to a maximum of 5 additional members
- C. 1 point for each 50 kilometers traveled in excess of 75 km (one way, most direct route). The reporting form must be signed by the visited club.
